our achievements:




UCU's Moot Court Team won the Henry Dunant Award at the Pan-African Moot and placed sixth in the African Human Rights Moot. The team will compete in the prestigious Jean Pictet Concours in Charlottesville, Virginia in April 2015.

UCU launched Uganda Nursing School Bwindi, an affiliate of UCU and passed 100% of the inaugural class.

Diane Stanton led her final official trip to UCU in April 2014 as Executive Director. Mrs. Stanton retired in June after over a decade of service. Mark Bartels was appointed to serve as the new Executive Director in July 2014.
